MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (hereafter referred to as the "MoU") was signed by the parties on this day,(Date).

A) **Allenhouse Institute of Technology**, Kanpur (Approve by AICTE , New Delhi and affiliated to APJAKTU , Lucknow) and having address at plot number 176, Kulgaon road-Rooma, Kanpur(herein referred to as the "First party" or "Institute") and represented herein by its Director.

B) **Future Academy**. (L/31A, Navin Nagar, Kakadeo, Kanpur, Uttar Pradesh 208025) hereinafter referred to as the Second Party" or "Company") and represented herein by its Founder or Director.

Whereas:

- 1) The First Party is involved in imparting technical knowledge and education where students come to shape their careers by taking degree and diploma in engineering and technology.
- 2) The Second Party is Future Academy, a company which provides the guidance for the developing of the soft skills. First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- 3) The Parties intent to cooperate and focus their efforts on cooperation within area of Soft Skill development training programs for the students to enhance their employment/ self-employment opportunities.

Now therefore, in consideration of the mutual promises set forth in this MoU, the parties hereto agree as follows:

CLAUSE 1: CO-OPERATION

1. First Party and Second Party are united by common interests and objectives, and they shall establish co-operation.

2. Both Parties co-operation will facilitate effective utilization of the intellectual capabilities.
3. The parties shall co-operate with each other towards mutual interest and are entering into this agreement responsibly.

CLAUSE 2: SCOPE OF THE MOU

2.1 Grammar in Speaking

Students will review grammar topics such as verb tenses, articles, and pronouns. Then, students will participate in speaking activities to identify, correct, and practice their own grammar use in spoken English.

2.2 Participating in and Leading Classroom Discussions

Students may find that they are required to participate in class discussions as well as lead classroom discussions about readings and topics from content areas.

2.3 Spoken English Fluency

This workshop will help make students aware of elements of spoken English beyond pronunciation, such as lexical "chunks", intonation, pauses, and syllable/word stress. Students will leave with exercises and further information on how to continue to develop their skills.

2.4 Impromptu Speaking

Students will practice speaking skills and formulating answers to respond to questions they haven't previously thought about. This type of "on the spot" interaction promotes language fluency and comfort level with spoken English.

Focus would be put on

- Art of conversation- dealing with parents and new students.
- Body language i.e their gestures, postures, dressing sense, facial impression.
- Basic etiquettes in their behavior and mannerism.
- Interpersonal skills- which include listening skills, making introvert students participate by encouraging them etc.

CLAUSE 3: VALIDITY

3.1 This Agreement will take effect on and will be valid for 3 Years from the date signed of this document. The MoU may be renewed for (years) upon mutual written consent of the parties before the expiration date. Each institution will have copies of this agreement.
